On November 12, 2017 at approximately 1712 hours, I Officer Hayes was dispatched to 10730 E Bethany Dr, 240 in reference to a disturbance.

I contacted employee/victim Maria Delgado 091368. Maria stated she was leading a diversity class when she noticed class participant Hashim Coates 100175 was video recording her with his cell phone. Maria stated she put her hand in front of the phone to prevent Hashim from recording her. Hashim then slapped her hand away from the cell phone when she did this. Maria was shaken up by this event and was noticeably upset during my contact with her. I did not see any visibly injury to Maria's hands.

Hashim stated a similar story to Maria's. He believed Maria was attempting to take his cell phone. Hashim said he pushed Maria's hand out the way when he believed she was raising her hand to take his phone. Hashim stated he did not slap Maria's hand.

Several witnesses in the office seen and heard this incident.

Maria stated she would not press criminal charges against Hashim if he would apologize to her. Hashim apologized to Maria and Maria stated she did not want to press charges. I left scene without incident.

This report is for information only. This concludes my investigation.
